Mr. Agrawal graduated in law in the year 2002 and is an enrolled Advocate. He practices mainly in New Delhi, but also appears regularly before Courts/Tribunals in other parts of the country.

He started his practice in 2003 in the chambers of Mr. Milon K. Banerji, Senior Advocate in New Delhi. Mr. Agrawal assisted Mr. Milon Banerji during the latter's tenure as the Attorney General of India (2004 to 2009) and represented the Government of India in various courts and tribunals. During this time, he worked extensively on several critical constitutional and commercial issues concerning the activities of the Government of India. He also advised several public sector undertakings on legal issues during this period.

Mr. Agrawal has also worked closely with Mr. Gourab K. Banerji, Senior Advocate who was the Additional Solicitor General of India (2009 to 2014), assisting in defending the Government of India and several public sector undertakings in several cases.

Mr. Agrawal established on his own as a counsel in the year 2009. He regularly appears on behalf of his clients before various courts and tribunals, and also instructs a host of senior counsels where required by his clients.

Mr. Agrawal has been involved as a counsel in several domestic arbitrations in New Delhi and Mumbai as well as international commercial arbitrations in London, San Francisco, Kigali and Singapore before Indian and overseas arbitral tribunals. He has also been involved in an international mediation. Issues involved in these arbitrations are varied and have ranged from construction and engineering disputes to loss of profit insurance claims. He has been appointed as an Expert Witness on several matters of Indian law in international arbitrations at Singapore and Dubai. He has acted as an Arbitrator on several occasions, including in a big-ticket construction dispute. Mr. Agrawal has also been appointed as Amicus Curiae by the Hon'ble Delhi High Court for assisting the Court in legal issues concerning Arbitrators' fee.

While representing the Government and public sector undertakings, Mr. Agrawal also gained a special expertise in dealing with oil and gas related issues, given the dominant presence of the Government and Public Sector Undertakings in the sector. That expertise has been fostered even after independently establishing in 2009. He regularly advises several MNCs and PSUs on issues arising out of relationships between oil and gas undertakings and other commercial undertakings and regulatory aspects of the oil and gas sector, including extensive advice with respect to the PNGRB Act 2006 and Regulations framed under it.
